

WINNETKA SCHOOL DISTRICT 36 HEALTH INFORMATION for 2020-2021

Student Health Requirements for the 2020-2021 school year are as follows:

All HEALTH FORMS are online at www.winnetka36.org on our district web page. Click on “Departments,” then click on “Nurses,” then click on “Health Forms.” Select the needed form. Hard copies may be obtained at your home school and or at the district office.

All medical forms are due **before** the **first day of school** and must be dated after the start of the previous school year to be considered current. .

The State of Illinois mandates a “**Certificate of Child Health Examination**” and or requires a “**Proof of School Dental Examination**” and or requires an “**Eye Examination Report**” upon entering certain grades (see chart or grade descriptions).

Students new to the district must have a child health examination, a dental exam, and an eye exam. In most cases current health documents for a new transfer student who has attended a State of Illinois school can be accepted.

Kindergarten students need a child health examination, a dental exam, and an eye exam.

Religious exemptions – From must be signed by one’s physician and parent.

Medication Permit is required for any medication taken at school, either prescription or non-prescription. This form must have a parent and a physician’s signature. A new permit is required each year.

Food Allergy Action Plan for any child with a severe food and or a severe bee sting allergy.

Asthma Action Plan for any child who is diagnosed with asthma.

Seizure Action Plan for any child being treated for a seizure disorder.

Diabetes Action Plan for any child who is being treated for diabetes.

All forms are available on the district website. If applicable, please obtain Food Allergy Action Plan, Asthma Action Plan, Seizure Action Plan, and Diabetes Action Plan from your physician. All medical forms are due before the first day of school.

Please note: Unless the student is homeless, failure to comply with the above requirements by the start of school of the current school year will result in the student’s exclusion from school until the required health forms are presented to the District...First time registrants have 30 days to comply from their date of registration.

These requirements can be found in The Winnetka School District #36 Policy 7:100.

Medical objection - a statement from the MD, DO, APN or PA indicating that an immunization is “medically contraindicated” is acceptable and will be attached to the student’s physical exam form in lieu of the vaccination. In case of disease outbreak, the student must be excluded from school. Should the condition of the child later permit immunization, the requirement will then have to be met.

Please make your appointment now and return the completed forms before the **first** day of school.
